Mobile learning and CPD apps

Learning and CPD content

Seminars and online events

Help members to manage and access their event enrolments.

Here's how to unify events with your digital learning content:

- Create stand-alone or blended learning programmes
- Invite members to seminar, webinar and online events
- Use workflows to approve requests quickly and easily
- Integrate with conference platforms like Microsoft Teams, Zoom, and WebEx
- Connect to Outlook and other common calendars.



CPD configuration

Agylia gives you flexible data forms to capture the exact CPD elements you need, using specific terminology.

Elements might include activity types, points, credits, learning hours, dates and targets. Custom validation rules can also be applied.

You use configuration to:

- Define points, credits, time or unit allocation based on different activities
- Apply custom validation rules
- Specify CPD start and end dates
- Tailor CPD targets based on membership type
- Capture internal and external activities for a full CPD history.

CPD planning

Planning is key to the CPD life cycle. Members assess their skills, competencies and future development.

Agylia helps you to:

- Define skills and competencies across membership type and levels
- Set structured development criteria
- Plan all learning and CPD, both structured and self-directed
- Review internal and external CPD plans
- Equip members with automated and manual reports.





Track and record CPD progress

Agylia offers automated CPD recording of digital learning and content, including courses, videos and online events. This helps to ensure that a member's CPD record reflects their learning activities and is up to date.

Where learning and CPD occur outside of the platform, members note activities on their CPD record. This can include, for example, seminars and educational events. They can upload evidence such as certificates and attendance confirmations. Members can also record reflections on what they've gained from their learning and CPD.

Members will take ownership of their CPD if you:

- Provide access to their record via a branded portal and apps
- Enable them to record structured and self-directed learning
- Highlight CPD progression and objectives
- Help them to upload evidence of activity completion
- Encourage reflection on learning activities.

CPD auditing

Use Agylia as your CPD review and audit platform. Members submit their CPD record to internal reviewers. They audit, give feedback and accept or reject entries, using two-way, automated communication.

Members can also export their CPD record at any time, ready for external review and audit.

Members will keep high standards for their CPD if you:

- Allow them to submit CPD records for internal review
- Enable internal reviewers to audit records
- Give reviewers the ability to reject records that don't meet defined standards
- Aid communication between members and internal reviewers
- Facilitate external review and audit of members' records.

Certification

Members should know how to achieve or renew their certification. You can build pathways that combine learning, refresher and update materials, and assessments.

You can track member progress through to certification with:

- An integrated learning and CPD platform for complete activities and histories
- Flexible learning that has mandatory and optional activities
- Automated management and escalation procedures
- Mapping of CPD frameworks
- Customisable and fully branded certificates.



Social learning and collaboration

In the right social environment, members become your strongest assets and advocates. Enable them to share knowledge by using integrated commenting capabilities.

Star ratings and/or 'likes' and usage statistics show your most popular items. This provides valuable insights into the quality and relevance of your content.
