

We do this in the following key stages:

Initiation



The key phases of a cloud migration project:

Project scope and costs

We'll take the defined success criteria and approach agreed in the Cloud Readiness Assessment to build a structured programme design to make your cloud project a success.

Detailed project design



We can pinpoint storage that's no longer required, and identify instances with little to no usage so you're only paying for what you need.




